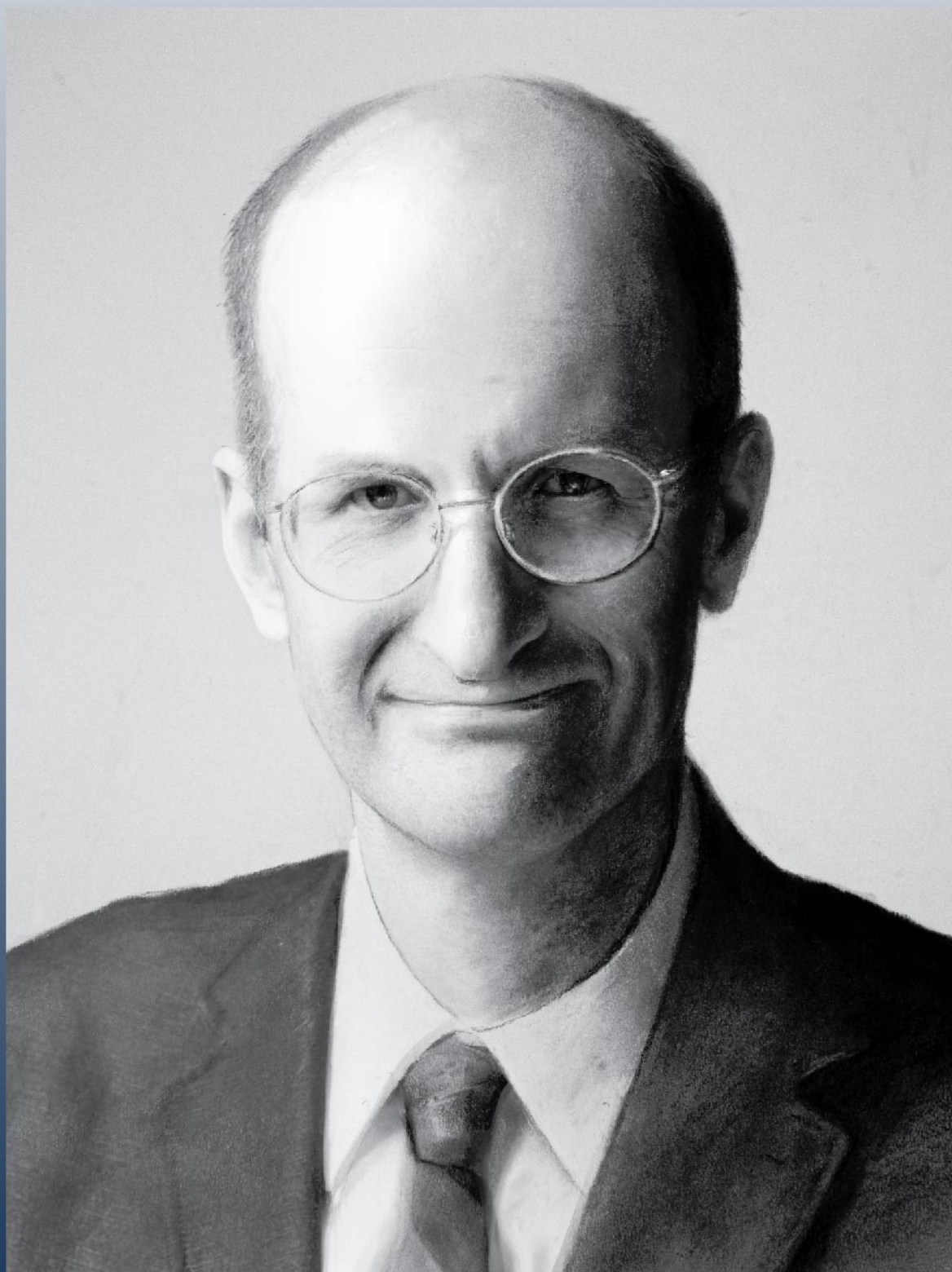

How to take down the Billionaires

Chapter One

Assessing our position in the middle of the battle

The entire Earth is administered today by a handful of ruthless billionaires who have used bribes, threats, assassinations, and plenty of other dirty tricks, to take over control of the systems for the distribution of information and to determine, in secret, the decision-making processes for government, corporations and other national and global institutions in almost all the nations of the world.

These billionaires and their advisors are slowly and systematically imposing totalitarian rule on the great majority of humanity through assaults on our minds via commercial media that dumbs down the population and inhibits original thinking and through paid-for authority figures who endorse criminal actions and thereby confuse citizens. They wage war on our bodies through forced vaccinations meant to weaken our immune systems and to introduce nano-sensors into the bloodstream that will allow for control via 5G and other systems. They have enforced lockdowns, and limited the activities of small businesses, as a means of destroying the economy of the people and rendering us dependent on services provided by multinational corporations like Amazon and Walmart, rather than local suppliers.

Finally, they have set out to destroy us spiritually, smothering our children in commercial materials that make them grow up thinking that we must depend on famous people and authority figures in government and business for inspiration and confirmation of reality. This evil process renders us incapable of creating our own communities wherein we can assess for ourselves the meaning of our lives and the spiritual aspects of our brief time on this Earth. Even churches are run (often in secret) as corporations controlled by the billionaires who make it their business to offer spiritual experience as a product for sale.

The billionaires have reached the high-tide mark in their power grab over the last few months. No one imagined they could get this far. It is a catastrophe like nothing in our experience. It goes far beyond the assault on society by the fascists of the 1930s. If anything, we are witnessing something closer to the fall of the Roman Empire in the 3rd century.

Although the situation is bleak, there is reason to believe that the globalist billionaires have overextended themselves, and that, if we are willing to take serious risks and think clearly for ourselves, and strategically, that there will be opportunities for a counterattack that could lead to their eventual defeat.

We will not be able to take advantage of these opportunities, however, if we do not have a critical mass of people around the world who are organized, who understand the true nature of the war, who are not swayed by momentary ups and downs, or misled into thinking that the war is over when the corporate media announces that some country has ended vaccine mandates, or has relented on lockdowns.

In this short book, *How to take down the Billionaires*, I relate concisely in twelve chapters what needs to be done at this moment to turn this war around, and how it must be done to be successful. I set forth strategies for breaking out of the false discourse on politics, economics and society that moves back and forth between the fraudulent celebrities of the left and right, who are groomed by the rich and powerful, like a pointless ping pong game.

We must first and foremost end the bogus discourse on policy choreographed by the globalists. These savior figures for responding to the current crisis that we are offered are, without exception, bought and paid for. Their primary function is to delude us into thinking something is being done when, in fact, nothing is taking place at all. They speak eloquently so that we imagine they are doing all the heavy lifting for us, and we wait to organize ourselves, and to think for ourselves, until it is too late.

Those of us who dare to oppose corporate fascism are exposed to defeatist and sensationalist reporting in the tame and harmless alternative media. That alternative media reporting complains about the crimes of the billionaires and laments the increasing totalitarian governance found around the world. It has lots to say about opposition to the globalists. But if you read the material carefully, you will notice that most of it is narcissistic complaining, indulgent criticisms of the sad state of affairs that encourage defeatism. Nowhere in these pathetic reports is there a game plan for how citizens can organize themselves to fight these global criminal syndicates, at the local, national, regional and international levels. These articles do not tell you whom you can call in your neighborhood, in your city, if you want to join the struggle.

That is no accident. The vast majority of alternative and conspiracy journalism is not intended to help you fight the globalists, but rather to make you think that Donald Trump, Robert Malone, or Robert F. Kennedy Jr. will do that work for you.

Many of these false revolutionists advocate, hold up as a model, some sort of leaderless, decentralized, mass movement.

History shows, however, that amorphous leaderless movements that promote awareness, and the exchange of complaints, have **never** succeeded in effecting change. If journalism does not offer you a way to get involved in the fight, to organize in your neighborhood, it is useless and dishonest by nature.

We must be concrete about what needs to be done, and how it must be done.

Sunzi's *The Art of War* offers an excellent introduction to the fundamentals of conflict and suggests how one can create a positive cycle for your side even in the midst of complete chaos, even when facing insurmountable odds.

Sunzi proposes that the key to success in any conflict is knowledge of oneself and knowledge of the opponent.

To know oneself, for us, is to possess an objective assessment of the strengths and the weaknesses of our anti-fascist movement, to maintain a long-term perspective on this struggle and not to allow hopes or fears to color our assessment of who we are, who we depend on, and what our true weaknesses are.

That means that we must objectively assess just how poorly organized we are, just how few of us are committed enough to take serious risks, and how we lack an overarching anti-fascist ideology that brings together diverse groups who are now hopelessly divided, intentionally, by ethnic and cultural boundaries. We must first see clearly our extreme dependence on social networks and on journalism that is underwritten, directly or indirectly, by multinational corporations. Whether it is our use of Google for searches, or Facebook and Twitter for communication, or Microsoft Word to compose texts, or Verizon to support our communications, at every single step of the way in our struggle, our efforts are monitored, undermined and diluted by our enemy.

To know the enemy means to accurately assess the strengths that are enjoyed by the super-rich through their complete control of the media and entertainment, of educational institutions and educational materials, of money and finance, of the legitimacy granted by governments, newspapers and universities, and their control of the corporations, banks and central governments that administer our nation.

At the same time that we understand their tremendous strengths, we must also grasp the weaknesses of the billionaires, whether that is the ill will they have bought among a large part of the population, the absence of any enthusiastic base of support at the local level for their ideas, or their overdependence on boring and uninspired media to push through their agenda.

They simply have bit off more than they can chew because they thought they could hypnotize the entire population of the world with their broadcasts and their articulate paid assets.

Equally important, it is critical that we grasp how their arrogance, their isolation from society as a whole, and their extremely small numbers means that they have tremendous liabilities if those who benefit from their largess and their patronage start to turn against them.

A careful and unforgiving analysis of our side, and of their side, an analysis that casts a cold eye on the political and economic realities of the moment, will be critical for formulating a short-term and long-term strategy for splintering them, disarming them, and then charging them with crimes, seizing their assets, and finally arresting them.

Actionable information about real power relationships, and the structure of the administration of the United States, and the world, by the billionaires, is precisely what is missing from the pathetic alternative media that wallows in “complainism” and narcissism. Sarcasm and the bitter tears drown the anti-establishment media, but it has precious little to say about how to take these guys down.

Narcissistic self-pity, delighting in dreams of the apocalypse, is precisely what the billionaires want us to engage in. But we are going to take this war to them.

Chapter Two

The weaknesses of the billionaires

The incredible success of the billionaires, of the corporate fascists, over the last two years of COVID-19 has radically increased their control over the economy and over the activities of citizens. This process has been shocking and discouraging. This success was not simply a result of their brilliance. It was a result of a deep moral bankruptcy among intellectuals, and other establishment figures, people who should have been responsible to the citizens, but rather chose to take scraps dished out by the rich in secret for misleading and confusing ordinary people.

So many establishment figures were happy to accept, and to endorse, that the basic services in the lives of citizens should be controlled by ruthless multinational corporations: Microsoft for writing and expression, Google for finding information, Facebook and Twitter for interaction with the world, YouTube for multimedia productions, etc. None of these platforms is owned by the people or run in a transparent manner by organizations dedicated to the public interest.

All of these services are run as a means of manipulating and misleading the people, but the establishment treats them as if they were transparent and accountable institutions granted to us by God.

The decision of so many, who knew better, to buy into this fraud, combined with their previous collaboration with the cover up of the 9.11 fraud, was the cause of the great unraveling that empowered the billionaires.

We are at the height of the crisis now, and it will get worse before it gets better. But the weaknesses of the billionaires are also increasingly visible.

The billionaires are so arrogant, so psychopathic in their thinking, and so narcissistic in their attitudes, that they must work day and night to convince themselves, and those around them, that they are in complete control of the situation. That desperate need to be in control is tremendous weakness. It means that, just like Hitler or Stalin, they cannot tolerate an open discussion of the facts that might reveal their weaknesses. They may have bought off all the leaders of major countries, but they cannot control the citizens and the local governments of the entire world. In fact, real resistance is starting to get off the ground, here and there, around the world. The question is whether it will form a long-term strategy.

Billionaires like Bill Gates, Jeff Bezos, and Elon Musk assumed that the control of massive banks of supercomputers that could be used to induce fear and promote mass psychosis via the media will be enough to render the vast majority of humanity as slaves incapable of any resistance in the next stage of this war. They assume that the strict control of food, energy and transportation by multinational corporations, which will be launched this year, will be enough to eliminate any resistance remaining.

They assume that the mass of humanity will never figure out what is happening before they are put in concentration camps, or injected with deadly chemicals, or reduced to imbecilic state by the commercial media or mental trauma. They assume that the tiny handful of those willing to give their lives in resistance will simply be overwhelmed by the mass of zombie-like consumers, and the sleepwalkers who run governments and corporations.

But their control of the system is far less perfect than they thought.

The situation today resembles the battle for Stalingrad in 1942. After being completely overwhelmed by the highly organized and focused German Wehrmacht, the Red Army finally learned to fight effectively, to respond aggressively to the attacks of the Germans, in the defense of the city of Stalingrad.

Like the Germany Wehrmacht in 1942, the billionaires today are overextended and too much of their hand has been shown to too many people. The blitzkrieg of 2020, the complete unity of government officials in all countries, of media outlets around the world and of celebrities and authorities who all endorsed the fascist COVID-19 regime, is no longer having the impact it was supposed to.

The German Wehrmacht rushed into the city of Stalingrad with complete certainty that they would quickly defeat the poorly organized Red Army. But the Russians of 1942 had learned much from the bitter defeats of 1941. Millions of Russians had died, or been captured, but the hundreds of thousands who survived had invaluable understanding of the nature of war.

The Germans foolishly relied on Romanian, Italian and Hungarian armies, forces who were not ideologically committed to Germany, and who were unprepared for a Soviet counterattack, and unwilling to give their lives for the German cause.

When the Red Army attacked the Romanian forces in earnest, they scattered.

Ultimately the German Sixth Army was cut off, surrounded, in Stalingrad where it was worn down, demoralized and eventually would surrender.

Similarly, today, the billionaires control the best army in the world, an army that takes the form of privatized intelligence firms that work hand and hand with the corporate media to shape public opinion, control social networks and search engines, undermine efforts at objective analysis and block meaningful organized resistance. They do so with equal effect around the world, grant the approach varies in accord with cultural and political differences, in Washington and Moscow, in Berlin and Beijing, in Tokyo and Paris.

However, large swaths of the employees working at multinational corporations, and of the government agencies that follow the commands of the billionaires, lack any strong ideological commitment to this Great Reset. Like the Romanians and the Hungarians at Stalingrad, the vast majority of those shock troops will crumble and retreat if they face a serious counter attack from those opposing the COVID-19 regime.

The billionaires blithely assumed that they could control the entire game by their strict regulation of information, by the promotion of a feckless and flaccid controlled opposition permitted to appear in the media, and by supplying concepts about society through their authorities that misled citizens as to what is going on.

But the game is evolving and changing as we go forward. The banks of supercomputers are extremely powerful, but reality is not like chess. Elements beyond the factors input for the calculation of future scenarios have emerged that raise serious doubts as to the effectiveness of this strategy of using AI to overwhelm humanity. The billionaires may be able to make up money out of nowhere, and to bribe just about everyone. But there is an increasing group of motivated citizens who cannot be bribed, or misled, or intimidated.

In fact, the AI systems that they use to manipulate us can be redirected against them, just as a cannon can be turned around and fired against the enemy's forces once friendly troops take a redoubt.

Billionaires made their money, and obtain their power by outsourcing to third parties and by claiming

that they possessed money lent to them by investment banks. But that money that they used to buy up everything was essentially made up out of thin air. Their wealth is a fraud and they rely on others for everything. Facebook, Amazon, Walmart, Microsoft and Google are empty shells once they lose their authority and their legitimacy.

If citizens remain weak and passive zombies, dependent on controlled sources for compromised information, then the billionaires will continue to be successful. If organized resistance emerges that not only complains that the billionaires are greedy and unfriendly, but goes on to argue, with proper documentation, that the billionaires in fact have no money and do not own the institutions that they claim to own in any real sense, then the tremendous weaknesses in their plans will be revealed, and their offensive undermined.

The Japanese philosopher Ogyu Sorai once wrote, "There are two ways to play chess. The standard way is for one to learn perfectly all aspects of the game, until playing is like second nature, and thereby to become a great master. The other approach is to make up the rules by which chess is played."

This insight into the nature of power is profound. If we follow the accepted rules for politics, economics and culture that are dictated to us by the current decadent and corrupt system, we will never win and we will constantly be undercut by these hidden parasites.

If, however, we make up our own rules concerning how the economy and politics are defined, and if we do so with confidence, and with authority, we can undercut the entire rotten edifice they employ to control us, and equally importantly, we can offer up something to replace it.

The billionaires assume that if they automate everything, if they use drones and robots to produce all food, if they control distribution and logistics, and patrol and to attack citizens with automated weapons systems, that they will be able to take over the entire world with just a handful of people.

Although the supercomputers calculated for them that this could be done, those supercomputers operated based on assumptions that were far from perfect. We already know from the case of Afghanistan that twenty years of attacks with robots and drones, and a variety of other sophisticated IT systems, was still not enough to beat a dedicated organization that was self-sufficient in terms of the economy and social organization.

There are many within the system who will turn on the billionaire class readily if they are convinced that we pose a serious challenge to this dictatorship, and that we are not just another PR gimmick. That means we must demonstrate the bravery and the will to go forward regardless of what newspapers are pushing.

We must make the argument that the billionaires own nothing but rather claim ownership based on questionable financial transactions and loans, and through criminal actions that we, the citizens, are justified legally, and in accord with the Constitution, in denying. We must formulate an entirely convincing argument, especially in light of the crimes of COVID-19, for why we must seize all the assets of these billionaires who threaten our lives and our livelihoods.

Chapter Three

Formulate a comprehensive strategy

If we do not have a long-term strategy, if we do not build a strong organization with a backbone of individuals ready to give their lives for the cause and with a clear vision for the healthy, equitable and free society we plan to establish, then no effective resistance will be possible.

The ground is littered with the bones of bogus people's movements that claimed that it was sufficient to fill in on-line petitions, to write letters to elected officials, and to rely on a class of high-profile narcissistic leaders who grabbed attention in the corporate media while leaving a complete vacuum for citizens at the local level.

Most of these "movements" were dependent on donations from the rich and powerful and infiltrated from the start by operatives working for the globalists. These resistance movements argued that they were effective because they were decentralized and without leaders. But such decentralized, weekend protesters, have never been successful in human history in effecting real change.

These popular movements are traps, scams, or dead ends.

The core of our movement must be a dedicated group of citizens who have sworn solemnly to defend their community, and the Earth, to the death if necessary, and who have promised to support each other, no matter what.

Without such a core, no movement can be successful when facing a ruthless and unforgiving adversary like the billionaires running our Earth. Those billionaires employ enormous privatized intelligence and military assets and can make up money for themselves, and their lackeys, at will.

If the leadership of our movement includes people who are worried about their retirement funds, or their children's college educations, or their medical treatment at elite hospitals, our movement will crumble when it is subject to real pressure.

The movement must have powerful local organizations so that anyone who wishes to join us is able to meet a local representative in person and to become involved in activities immediately. Those activities must be substantial and aimed at building even more powerful local organizations. Almost none of the so-called opposition groups today offer local members an opportunity to participate in planning and action. Most are run as dictatorships; whatever progressive names they may employ.

We must say to citizens what Martin Luther King Jr. said in the 1960s,

"Somebody must say to America, 'America if you have contempt for life, if you exploit human beings by seeing them as less than human, if you will treat human beings as a means to an end, you thingify those human beings. And if you will thingify persons, you will exploit them economically. And if you will exploit persons economically, you will abuse your military power to protect your economic investments and your economic exploitations.' So what America must be told today is that she must be born again. The whole structure of American life must be changed."

That project can only be realized by powerful, structured, and rigorous organizations at the local level that will serve as the vanguard. Such a transformation cannot be brought about by the famous people speaking on television. No matter how hard they may try, no matter how good their intentions may have been, they will be reduced to objects for narcissistic consumption, not serve as catalysts for substantial transformation. The local organization, when prepared, will go directly to local government, to local corporations, to local NGOs, and will demand that they follow the Constitution and the law, and desist from all cooperation with the criminal COVID-19 regime. They will demand the resignation of, or the arrest of, all those government officials, and corporate CEOs, engaged in promoting the COVID- 19 fraud.

The careful integration of strong local organizations with equally strong national, regional and international networks, will make these offensives against the globalists substantial, taking advantage of the weakness of the billionaires at the local level.

The organizations leading our revolution must feature a democratic and participatory structure that allows those at the lower levels to make proposals that are then considered and implemented at the national, regional and international levels. It is the fully participatory nature of our movement that will set it apart from the entertainment and distraction generated by political parties, NGOs, media and universities funded by the rich.

Most of those organizations, which pretend that they are entitled to discuss policy with authority are in fact propaganda units that present themselves as concerned about the people, but that serve a tiny elite that refuses to have any substantial discussions with the actual members of the organizations, let alone with ordinary citizens. They will not adjust their policies to reflect your concerns. No, these NGOs and political parties serve only to propagate public relations material decided in advance by the billionaires and their consultants.

We need organizations that are ready to fight at every level against the corporate fascists, people who are willing to question every action that corporations and government take, and to block those criminal actions with words, with protests, or with their own bodies if necessary. We need organizations that have weekly meetings wherein people have their concrete assignments and pledge to support each other, and to fight for freedom and independence at any cost.

Ultimately we must create an international alliance against corporate fascism like the anti-fascist alliances of the 1930s, alliances that brought together both left and right, Christians and socialists, for a united front. The numbers involved need not be that many at first. It is the dedication, and the will expressed, that will be decisive. We have had enough of pliant and supine organizations claiming millions of members, that cannot do anything to resist fascistic policies.

When we reach out to citizens, we should ask them what they need and offer to help them as best we can. Unlike any other organizations, we must offer real membership and real support.

We will also start an honest discussion about how the United States (or other countries) are actually run. That discussion must be based in facts and avoid the foolish terms like “leftist” or “conservative” promoted by the public relations firms paid off by the billionaires to divide us and to confuse us. We will describe in detail the global alliances of intelligence and military operatives who have taken over effective governance, and left national assemblies, prime ministers and presidents as mouthpieces who convey what the corporate powers have already decided.

The definition of government must be a central part of our engagement with citizens. It is a huge mistake to attribute all evils to bad government. It is an approach that is encouraged by the wealthy.

Although government is never perfect, we need to establish a functional government that will replace the criminal syndicates that pretend to be “government” today. To say that the government is bad only encourages despair among citizens. To state that the privatized criminal organizations that are running the country are not government, but that we will create a real government again, is a statement that has tremendous power and can inspire real change.

If government followed the Constitution, and worked for the citizens, it could be the organization that will lock up the billionaires and seize their assets. Restoring government, not encouraging cynicism, must be our goal.

Those privatized parts of intelligence, Justice, Energy, Defense and Commerce that are destroying the lives of citizens, and hunting us down, must be defined as “criminal syndicates” that pose as “government.”

The spirit of the Constitution, an inspired document despite its limitations, should be a critical part of our effort. Without a functional Constitution, there is no United States government and government representatives have no authority to tell us what to do without the Constitution.

Finally, the ultimate authority, the Constitution and Declaration of Independence, stress repeatedly that the citizens have the right, and the obligation, to overthrow a tyranny. Citizens must understand that their actions are not domestic terrorism, but their duty as citizens granted by the Constitution in response to this massive criminality that has infected our nation.

Chapter 4

Stop complaining!

The billionaires want you to complain to each other, to bitch about how unfair and greedy the rich people are, and even better to blame it on Jacob Rothschild or George Soros, on the Free Masons or the Vatican, to get angry at sad old men like Joe Biden or Donald Trump, who basically do what the billionaires tell them to.

Such people, and organizations, are deeply corrupt, but they are but a small part of the massive parasitic class of billionaires and their minions that extends to Oracle, Coca Cola, Bank of America, Amazon, Walmart, and Google—brand names never associated with this evil in the so-called conspiracy media.

The billionaires encourage useless complaining, complaining that makes people feel they have done something when in fact that have not done anything at all. What they do not want is for you to organize yourselves, to talk with your neighbors about what is happening in our country, or to plan a concrete strategy for retaking control of government.

There are plenty of entertaining articles about small fish like Anthony Fauci that will take up your time and give you plenty to complain about when drinking a beer with your friends. Those articles, for the most part, are generated so as to make sure you waste your energy complaining, and do not form effective strategies for meaningful political combat.

We must focus on the big players, demand that all their assets be seized, that all documentation related to their crimes be made public, and that they be jailed.

We need to form teams who walk around the neighborhood and who make sure that everyone knows exactly what is being done by these criminals and what we are obligated to do in response as citizens. If we are diligent, we will be able to compete with, and surpass, the lies and frauds repeated on in the corporate media.

It is critical to narrate the true story in a manner that ordinary citizens can comprehend, and do so without sensationalism. Most people know there is something profoundly wrong in our country, but they do not understand exactly what it is that is wrong. Once they realize that the billionaires were criminals from the beginning, and that they have no rights to any of the money that they claim to possess, the entire political discourse will be altered and new revolutionary potential will be unlocked.

We must explain how the billionaires came to completely control the media through concentration of reporting in the hands of a tiny number of multinational corporations, and we must make clear the details of the political process in Washington, and how transportation, distribution, retail sales and all exchanges between citizens via the internet are organized so as to strip citizens of their independence as granted by the Constitution.

Part of this process will involve filing legal petitions at the local level that detail the nature of the COVID-19 regime, explain its blatant violations of the Constitution and local laws, and we will demand the jailing of all local officials who have been involved in these crimes.

When the first demands for arrests are made, they will be laughed off, ignored, or even punished. But if we keep on coming back in a systematic manner, using sophisticated and convincing language--far beyond the propaganda fed to us by the media--then many who sit the fence now will start to support our efforts to lock up the responsible at the local level.

When we compel politicians and government officials at the local level to reveal how they have been bribed and intimidated, how they have signed secret and illegal contracts with multinational corporations to promote vaccines and social distancing, we will be ready to take the next step, pressing charges, and demanding arrests at the Federal level.

But trying to arrest the big fish from the beginning is a mistake. We are more likely to have breakthroughs at the local level where we can organize provisional governments on a scale that can overwhelm the corrupt local governments in the service of the billionaires, and actually arrest those responsible.

Critical to this plan is raising the self-confidence, the spiritual insight, the awareness and the intellectual capacity of working people so that they feel comfortable, and entirely in their right, to judge these criminals with fancy outfits and Ivy League degrees, and they can no longer be intimidated by innuendos or by symbols of status.

Human nature has tremendous weaknesses which the billionaires have preyed on mercilessly. But there is a feeling of excitement and inspiration—and of freedom—that comes with learning the truth and that can inspire ordinary citizens to rise above the bland lives to which they have been subject.

It is extremely effective to give citizens handouts that are scientific and systematic in their explanation of how the world really works, going door to door. Many people who pretend indifference on receiving such materials will go home to study them with great intensity.

We should explain that there are no good guys left in this system and invite citizens to join our local revolutionary teams.

These dedicated, potentially risky, organizing activities these will be effective in a manner that chatting with friends on Facebook will never be.

Once the kingpins behind the criminal coup d'état in the United States are identified for ordinary people, and their actions become common knowledge for the common man, we will be ready to start taking them down, one by one, starting with the cat's paws, the lackeys, and the quislings that they cultivate at the local level.

The takeover of our society by the billionaires and their lackeys cannot be understood unless we grasp how a veil of secrecy has been spread over most of the government and over corporations for the last twenty years that makes it impossible for people to even speak about the horrific crimes that are destroying our nation. It has become common sense for most people in the upper middle class to simply assume that there is a set of issues which are simply taboo, which cannot be brought up in any context, ever.

President John F. Kennedy addressed this crisis of governance by secrecy at the beginning in a brave speech he delivered in April of 1961.

President Kennedy spoke,

“The very word ‘secrecy’ is repugnant in a free and open society; and we are as a people inherently and historically opposed to secret societies, to secret oaths and to secret proceedings.

We decided long ago that the dangers of excessive and unwarranted concealment of pertinent facts far outweighed the dangers which are cited to justify it.

Even today, there is little value in opposing the threat of a closed society by imitating its arbitrary restrictions. Even today, there is little value in insuring the survival of our nation if our traditions do not survive with it. And there is very grave danger that an announced need for increased security will be seized upon by those anxious to expand its meaning to the very limits of official censorship and concealment.”

A massive increase in secrecy in the United States started after President Kennedy’s assassination in 1963, a blatant attempt by global finance to intimidate all politicians that was complemented by the expansion of classified status to cover any document that revealed criminality in government. This move was combined with a purging of committed and responsible individuals from the Department of Defense and from intelligence.

That trend towards secrecy went into an exponential upwards curve after the 9/11 attacks. Those attacks involved massive conspiracies to destroy the functionality of government, to mislead the public about fundamental policy decisions, and to threaten, or suppress, opposition while launching endless foreign wars. Laws were set in place, many of which remain illegal to even mention, that set stiff punishments for the disclosure of the truth in any format, for any reason.

To this day, although the contours of the fraudulent attacks on the World Trade Center are known to many, the actual internal process by which it was planned, coordinated, and implemented remains obscure.

There are three main approaches to making secret the corruption and criminality that has spread across government and corporations, and to punishing anyone so foolish as to search for the truth: 1) the use of classifications (secret and top secret), 2) the use of secret law, and 3) the use of non-disclosure agreements.

Rendering corporate and government documents detailing institutional criminality as “secret” and “top secret” and punishing anyone who refers to the criminal actions with massive fines and jail terms for violating the conditions for security clearance, is an old trick that has been radically expanded over the last decade. Numerous whistle blowers have gone to jail and have been driven into bankruptcy, for simply speaking the truth for the good of the nation. Many are subject to courts agreements, to keep them out of jail, that bar them from even discussing what was done to them illegally.

These days, whistleblowers are few and far between because in the current reign of secrecy, those who violate the rules will be punished without anyone ever knowing what happened to them. There seems little point in the growing darkness of risking one’s life and livelihood.

Just about anything that might get someone in trouble for corruption is immediately stamped as classified and thereby rendered off limits. This practice is what has allowed for the theft of hundreds of billions of dollars by investment banks and multinational corporations from the Department of Defense and the Central Intelligence Agency (and elsewhere) over the last two decades—without a trace. It is also the means that permitted investment banks to steal trillions of dollars from the Federal Reserve in 2020, an act that fundamentally transformed American society by creating such a concentration of wealth as to establish an untouchable all-powerful ruling class.

That could not have been done if most pertinent documents in the Treasury Department and the Federal Reserve had not been classified as top secret (in an egregious act without precedent).

These days, documents are classified by the FBI, the Treasury Department, the Coast Guard, the Department of Commerce, and yes, of course, the Center for Disease Control, on a daily basis to protect the interests of investment banks and the billionaires who run them.

This new culture has rendered a government that was already fatally wounded by 9/11 into an undead, zombie criminal syndicate that does the bidding of the very few.

Secret law, as opposed to classification, is a law, or laws, passed by the Congress which has the full impact of Federal Law, but that remains secret and for which you can be punished for discussing the existence of.

The very concept of secret law is so blatantly unconstitutional that you would have thought people would be screaming from the rooftops about it. But, in our sad age, decadent intellectuals are too compromised, too caught up in their own little worlds, to worried about their retirement funds, to care about such matters.

I cannot describe here all of the ways in which secret law is employed in the United States to support a shadow government that makes decisions long before any institution described in the Constitution

can take action. Secret law is employed to block people from running for public office, or to make sure their ideas are never covered in the media—no matter how relevant their arguments may be.

Secret Law renders topics taboo in debates on policy in government, think tanks, universities and the media, debates on many important issues. It is not simply that the media does not want to cover the truth because of its corporate interests. It legally is not permitted to do so.

Those who violate the regulations of secret law in their pursuit of truth are brutally punished, but their punishments remain unknown to the public, or even to friends.

Finally, there are non-disclosure agreements which people in business and government are forced to sign from the start if they want to have a job at all. These agreements include enormous fines, and other punishments, for any disclosure of the criminal actions of the organizations that demand the use of these agreements.

In addition, there are non-disclosure agreements that are forced upon citizens by courts whereby, in order to avoid jail and fines for speaking the truth, citizens must sign agreements that prohibit them, forever, from relating the details of the criminal actions by corporations or governments that led to their misfortunes.

The implications of this sweeping institutional secrecy in the United States, at all levels in the Congress, and in the Federal Government, and extending to corporations, banks, and privatized intelligence and law enforcement, are grave.

More and more critical issues in the United States are becoming taboo, more and more criminal conspiracies are off limits for the media, for academics, and even for the man in the street.

This empire of secrecy is the primary driver, not the foibles of any particular politician, that is behind the catastrophic institutional collapse taking place in the United States today—a collapse that is starting to resemble, under the COVID19 regime, the end of the Roman Empire.

We cannot make any progress in stemming the flow of the lifeblood of our nation until we take on the unconstitutional walls of secrecy that have shut citizens out of the policy process, shut down the fundamental functions of government, and made possible the current totalitarian governance system.

At this point, all classified materials must be made public with only exceptions for ongoing discussions on treaties and agreements. All secret law must be deemed to be illegal and unconstitutional by its nature and made public, and the criminal enforcement of non-disclosure agreements must end.

Chapter 6

Don't outsource the movement!

The organizations that support the movement to take back control of governance from corporations and corrupt government must be internally strong and must be controlled by people who are dedicated to the movement and to moral principles. It is critical to avoid depending on money given by the rich, and outsourcing functions to for-profit firms that have other motivations than revolution--and are most likely subject to pressure from the super-rich to undermine and to weaken our efforts.

The concentration of wealth, and the emergence class society in the United States, means that most movements and NGOs are dependent on the funding, seen and unseen, from the wealthy who are indifferent to, or even hostile to, the needs and interests of ordinary people. It is critical that we avoid the trap of dependency on class enemies from the start as we build a robust and serious movement.

Do not outsource anything to anyone. It is better to have regular meetings in person, to exchange document written by hand by post than it is to have corporate operatives undermining our efforts at every turn. And that includes criminal operations with a human face like Google, Microsoft, Facebook and Twitter.

Every time you use Facebook, Gmail, Twitter, Google or YouTube, you are allowing a multinational corporation not only to know what you are doing, but also to determine who can see what you produce, who you can reach, and, in many cases, what actions you can, or cannot, take.

Your smart phone, for that matter, does not belong to you. Corporations are capable not only of accessing all the information in your smartphone, but also of changing the programs used by it, altering what you find in searches through it, and determining whom you can communicate with easily. We will need to make sure that all of these processes are controlled, eventually, by a transparent constitution of information. For the moment, we need to control as much of our activities, of our message, and of ourselves internally.

Our goal is not to beg the criminal syndicates that run YouTube and Facebook to be more fair, to let us reach more "customers." Our goal is to destroy these privately-owned means of communication and education which have become monopolies by using criminal methods to block out all their opposition; we will replace them with cooperatives that are transparent, accountable and run by the people. That shift in the management of technology must start within our own tight-knit organizations first.

In this process, however, it is critical that citizens first realize just how corrupt, just how broken and just how dangerous the current system is. Google and Facebook spend billions of dollars to convince us that everything is fine as the offer their role as propaganda platforms to serve multinational corporations and the super-rich. They use secret law and other illegal means to force us to depend on their monopolies and to block anyone who tries to replace them with transparent, user-owned cooperatives. These obvious alternatives to multinational social media and information systems are blocked out of the media by these criminal syndicates.

We may be forced to use their services at the start, but we must be clear with ourselves that eliminating them, and ending all outsourcing, is our primary mission. Social media, search engines and other

services run by multinational corporations can never work for the interests of local communities.

Chapter 7

Form independent communities

Our front against corporate fascism cannot be a weekend hobby for the well-to-do. It must be a 24 hours a day effort that is supported at every step by our independent communities.

At the core of this movement will stand a network of 100% economically independent, intellectually independent and self-sufficient communities. The number of these cooperatives and communities may be small at first, but once we have a model that can be exported, they will increase rapidly.

Economically independent means that we can produce our own products (clothes, furniture, tools, housing) within the community, create our own currency and our own barter system that is 100% independent of the Federal financial system, and we can grow our own food to the best of our ability without relying on the monopoly of distribution and logistics, the wrapping of everything in plastic and paper, the taxes and charges on everything that we eat, and the pesticides, herbicides and petro-fertilizers and the GMOs that cost us and kill us. If we get these vampire middle men out of the way, our movement will be far more powerful and we will not have these parasites sucking our economic lifeblood.

Intellectually independent means that we avoid the commercial television broadcasts that are meant to dumb down the population, and we create our own independent journalism and run our own alternative schools for our children. We will engage in discussions among citizens concerning local, national and international issues that will allow for a rational and informed discussion without the fluff, the hype and the blatantly anti-intellectual agenda of the corporate media.

That means that we will avoid like the plague the thought leaders that corporations force-feed us and rather strive to increase the intellectual independence and capacity of all citizens; we will recognize the potential of all to rise to the intellectual level demanded of them as citizens.

A pledge of membership and of joint ownership of the village, the community, that we join is an extremely effective means of creating a clear awareness of our independence through cooperation.

We will welcome to our growing communities those who were laid off in the COVID-19 firings, those who have been economically destroyed by lockdowns and other political attacks, and those persecuted for not taking vaccines. Moreover, the farmland that multinational corporations and billionaires like Bill Gates claim to possess belongs to our communities. In accord with the Constitution of the United States, we do not recognize the purchase of our precious farmland, critical to our survival, by billionaires and multinational corporations using fake money and other financial tricks. They own nothing.

Chapter 8

End the cult of the self and stop corporations from inducing narcissistic behavior

If you are serious about opposing global corporate fascism, you already have had the experience of meeting citizens, friends and family, who have been reduced to passive consumers by the hypnotic television, who are incapable of conceiving of their relationship with society other than in terms of how much money they can make and how much they can buy, and who lack the imagination required to comprehend the global takeover underway now—which is not described by the network news.

The multinational corporations have paid their lackeys to create a corporate-controlled system that establishes norms and values for citizens that are not natural but rather induced. The process, which has gone on for a century, is so blatantly unconstitutional and so clearly an effort to reestablish slavery in violation of the 13th, 14th and 15th amendments.

The traditional values of frugality, modesty, sincerity and loyalty have been obliterated, through a systematic brain washing program introduced into the mind through toxic injections of entertainment and sensationalist journalism. In place of healthy values and love between family members, cooperation between villagers, we face the false god with a hidden face that ruthlessly demands of us competition, personal achievement, self-improvement, and straight out narcissism and greed, as the basic values, the new religion, for citizens.

The potential for organizing communities and effective movements has been undermined, no! destroyed, by this narcissistic view of the individual in a struggle for self-aggrandizement, best known as the “cult of the self.”

The cult of the self is an advertising and public relations campaign, which can be traced back to the 1920s, that is intended to induce dependency on consumer products (which means dependency on corporations) and to encourage passivity and self-obsession. It is promoted in music videos that stress wealth and self-importance, narratives about love that focus on personal experience and ignore family and society, movies that feature superheroes that are independent from their communities, fashion magazines that suggest the only road to happiness is consumption and looking good in the eyes of others, and a broad range of self-help experts who suggest that we must learn from billionaires, or blame ourselves for our lack of personal enlightenment if we are disturbed to see a predatory and cannibalistic culture around us.

The cult of the self does everything possible to erase and obscure class warfare, the need for solidarity in communities, the importance of taking care of family and friends, and the critical virtues of humility, modesty, frugality and compassion.

Linked to the cult of the self is the glorification of technology and the promotion by corporations of the idea that an iPhone or a Facebook post will improve one’s emotional and spiritual experience. Technology is always dangerous, always potentially destructive, for society and culture, and all choices regarding technology must be made with extreme care, and in an open and participatory manner.

If we have corporations introducing dangerous 5G technology in our neighborhoods without review by citizens, we are living in a totalitarian state.

What is lost in the promotion of technology and narcissism is the capacity to engage in rational and detached thinking, to slow down enough to read a book or to consider a complex issue in three-dimensions. In other words, narcissism destroys the capacity of people to serve as citizens and guts the constitutional system which is supposed to undergird all governance. Corporations that induce narcissism through advertising are engaged in a criminal and treasonable action.

The promotion of narcissism and the resulting drop in the ability to concentrate and focus on the part of citizens, means that those citizens fall for bogus high-profile protests and are convinced that government is doing something when some toothless law is promoted by the self-appointed experts.

That is to say that the vast majority of citizens are no longer capable of assessing what is actually taking place with detachment, and following the scientific method.

If we wish to take down the billionaires, we need to first create a culture in daily life that offers an alternative to this deadly web of indulgence and sloppy thinking woven by the rich and powerful so as to entrap us all.

Democracy is the process by which the needs and the wisdom of the people are converted into policy. But if the people are misled, sated with distorted and embellished journalism, if they are taught to be self-indulgent and thus lose interest in governance, then we have a democracy without people. If the debate on policy is not grounded in truth, then we have a fantasy democracy. However, and this is the hard part, truth is never democratic. If we are voting to determine what is true, then we have already slipped into an orderly, and all too reasonable, psychosis.

We must determine what is true first and then move forward with our revolution.

Chapter 9

Take control of the economy

The primary source of the billionaires' power is their control of economic activity through a shadowy set of alliances with multinational corporations and investment banks. They are able to create money for their use out of thin air through central banks and to use that money to bribe, to purchase real assets, and to develop the technologies they require to control the rest of humanity. For the most part, we are talking about supercomputers for processing all the data collected and satellites, CCTV cameras, drones and other spyware for collecting it for their use.

This scheme to control the global economy works as long as the population accepts the myth that these billionaires earned the money that they use, that they own the assets that they claim to own, and that the money they use to finance their projects actually exists.

Resistance to this economic take over must take two forms.

First, careful documentation of exactly how the billionaires use investment banks, and intelligence agencies (mostly privatized these days) to create their wealth artificially and to force their will on the citizens of the United States needs to be written up and to be distributed to all citizens so that we increase awareness of how the nation actually works.

That education for citizens is a critical stage as most of the critiques of the billionaires that people are exposed to are emotional simplistic conspiracy tracts that do not explain how the system works (even though they may accurately describe criminal actions) and therefore such materials do not help the citizen to formulate a strategy for taking these billionaires down.

For the most part, the message is that some billionaires are greedy and unfair and let us just be mad at them.

Second, we need to create our own independent and self-sufficient economy that allows us to avoid the insidious influence of global finance and we need to set up systems for economic and financial interaction at the local level that can later be extended to cover the entire country and will replace the corrupt Federal Reserve and the network of parasitic banks that currently runs the United States for the benefit of corporations—many of which are headquartered outside the United States and are not “American” in any sense of the word.

Once we have formed small and dedicated groups of citizens at the local level who have pledged to fight for freedom and the rule of law, and to support each other throughout whatever trials we may encounter, we must create our own independent economic system.

That starts with money, the object we use for all exchanges but over which we have no control and whose value can be increased, or decreased, or even eliminated, by the hidden forces in global finance. Their insidious plans to replace currency with digital money that can be turned on and off by hidden forces without the permission of citizens, is a tremendous danger that we face today.

We need to establish in our communities our own currencies, currencies tied to the barter exchange of products, food, and services between citizens that is 100% independent of the closed empire of logistics, distribution and retail sales controlled by a handful of billionaires. Such a currency will be based on

substantial and the tangible things and thus unaffected by the inflation cooked up by billionaires to rob us.

Malls, franchises and branded products form the backbone of a non-participatory vampire economy that has replaced the independent local economies that once existed in the United States. Most cannot even remember that we once had healthy independent local economies in which clothing, tools, furniture and food were produced in the region, thereby assuring that all money stayed at home and all jobs were local jobs.

Every time we must purchase something at WalMart or Target, at Whole Foods or Starbucks, a large chunk of our money leaves our community and ends up in the pockets of the billionaires through these economic dictatorships that rule the American economy.

We do not need, or want, more jobs created by multinational corporations, or their offspring, jobs financed by massive investment banks, or supported by a Federal government that spends non-existent money to create short-term effects with the result that our money is stolen from us over time by inflation.

If we can produce everything in our local community, all profits stay in our community. We can make real jobs in the community in which the worker makes his or her own decisions and does not have the billionaires pulling strings through biased job requirements cooked up to control us.

That sort of economic independence will change the entire equation and give us new power in this battle against an entrenched and ruthless class of global billionaires.

We must clearly identify and describe the dictatorship of distribution and logistics, of marketing and finance that robs us at every step in our lives. Sadly, most alternative media outlets, afraid of the power of big money, complain about politicians but do not describe in detail how the economy actually works, let alone how we can obtain economic independence.

Citizens must be educated about the multinational corporation and its true nature as part of our revolution. Apple, Google, Coca Cola, or Amazon are not American corporations. These multinational entities serve a tiny handful of the elite around the world and pay minimal taxes while exploiting the people.

Politicians who talk about jobs and pay but who never talk about assets, are simply there to distract you.

The mass criminality of billionaires over the past thirty years is, in itself, more than enough justification to seize all of their assets.

Yet the corporate media has convinced the people that these criminal syndicates are somehow American, that we should support them against threats from China and Russia, threats often cooked up by those very multinationals.

We are taught, in school, and the story is repeated by the corporate media, that the economy is determined by growth and consumption, manufacturing, exports and imports, interest rates, and above all, by the stock market. Every day much of the newspaper and of the evening news is filled with reports about such economic activities which supposedly follow scientific principles laid down by the rational field of economics.

But economics is as scientific a field as is alchemy, witchcraft, or bloodletting with leeches. Most the prescriptions for happiness presented as holy orders by the economists are in fact detrimental to the lives of citizens.

Growth is a made-up concept that demands that we waste needlessly and extract and destroy natural resources endlessly in order to live a better life. There is no scientific basis for the demand for growth and extensive evidence that it is destructive for the lives of citizens and has a negative impact on resources and on the environment because it is obsessed with short term effects and blind to long-term consequences.

Growth is tied to the psychosis of consumption that holds that unless we keep buying and throwing away things that we do not need, the economy will collapse. The result of the consumption ideology is that if you build a house that will last 300 hundred years, craft a table that will last 100 years, knit a sweater that will last fifty years or darn socks that will last ten years, you are engaging in a crime against this sacred economy. If you grow your own food, or spend time taking care of your sick mother, these actions that have no meaning, are a negative for the economy, for growth, for the GDP.

Most items that we buy at the store are made overseas-requiring that they shipped for thousands of kilometers, wrapped in paper and plastic, and only available through layers and layers of middle men.

We have been sold the falsehood that we must export and import in order to grow as an economy and that such growth is essential for the lives of ordinary citizens. In fact, global trade, the death cult of “free trade,” is destructive to local economies and has been used by the rich to weaken the economic independence of citizens, thereby making them slaves.

Anything that comes from China or India, from Mexico or Thailand, must pass through the hands of multinational corporations multiple times. They take their pound of flesh at every turn, and they make sure that they are in a position to raise prices, or even shut down the local economy, at any moment.

The primary news in the economic section of the newspaper is interest rates and the stock market. It is assumed that these are fundamentals to our economy that must be carefully tended to by experts for the sake of our betterment.

I will not pretend to understand the sordid and secretive system by which multinational banks set interest rates and how they use those interest rates, and exchange rates, as a cudgel to punish those beneath them who try to help the people. All I will say is that the entire system is run in secret, completely outside of the constitutional framework of the United States, and therefore has no legitimacy.

The stock market is equally horrific. This system allows investment banks to collude with the CEOs of corporations to create value out of nothing. The stock market, run by for-profit corporations like Nasdaq allows corporations to create value through their stock by using money borrowed from the banks, or given by the federal government, to buy back their own stock. It is a Ponzi scheme on a massive scale.

The Constitution makes no mention of the stock market and government institutions have no responsibility to support this criminal enterprise. The fact that we have been lulled into relying on a dangerous and unaccountable institution outside of the framework of the Constitution means that it will be difficult to transition to a democratic and participatory economy. But, granted the deadly schemes been undertaken by the COVID-19 dictatorship, we have no choice.

Creating an economy focused on production by citizens, in accord with the word and the spirit of the Constitution, must be our goal. Not only must we expose the fraud of Wall Street and the rigged stock market, we must propose an alternative economic system for United States that is focused on needs of citizens and that supports the local economy, and is not reliant on “trickle down” from global economic exchanges by multinational corporations.

It is important to stress the critical role of food production in the battle for freedom and independence.

The billionaires have targeted the control of agriculture as high priority because they plan to starve those who resist them at a later stage in this war. They have already amassed immense amounts of farm land on which multinational corporations use automated systems to grow GMO crops, doused in pesticides and herbicides, in soil poisoned with artificial fertilizers, for the consumption of the people.

The intention is gain complete control over food production without any humans involved in the process.

Although this dangerous preparation for the next stage of class warfare is completely ignored by the corporate media, we must be ready to supply our own food, and to challenge the authority of billionaires to buy up farm land that belongs to all citizens using phony money made up by investment banks.

Chapter 10

Save the intellectual and reestablish education

The billionaires could not possibly have gotten away with a scam on this scale if the intellectual foundations on which the nation depends had not been rotten to the core. Most citizens are too busy just trying to get through the day, to feed their families and make ends meet. They must depend on a small group of experts, who have the training and the knowledge that they will never be able to obtain themselves. They depend on experts to explain to them what is happening in the world, how it effects them and what needs to be done in response.

The Treason of the intellectuals

These experts, intellectuals in the technical sense, are professors, researchers, lawyers, doctors, journalists, engineers, and a variety of other specialists in business and government whose job it is to identify the problems we face, present a rational and understandable analysis, and suggest solutions going forward.

Most of these intellectuals, have betrayed the trust of the citizens, leaving them blind before the onslaught of global finance. This betrayal is what we refer to as the treason of the intellectuals.

They have taken secret bribes to promote false stories about the 9.11 incident, the Patriot Act, the transformation of the military and intelligence into a secret government, and the COVID-19 pandemic. Although they received their training, and conduct their activities, with the support of tax dollars from citizens, they have descended into a narcissistic fantasy world in which their fame, and their personal needs, are central and they feel no obligation to sacrifice themselves for the benefit of the people.

Intellectuals are absolutely necessary and must play the central role in educating and leading citizens who do not have the luxury to focus on science, technology, economics, international relations, or history.

The battle against the billionaires' demands that we restore the dignity and the sense of responsibility to intellectuals. We must support a new generation of intellectuals who are not looking for profit, or personal fame, but who are dedicated to the long-term interests of the citizens.

Corporations have invented bogus academic stars like Yuval Harari or Jordan Peterson to push a vision of the world in which the individual is central, not social organizations, and self-realization is the core task. In the false world of the paid-for intellectual, all responsibility lies with the individual and the parasitic corporation becomes invisible.

At the same time that these famous, inaccessible, stars, lecture us from on high, the actual intellectuals in our neighborhood, professors at community colleges, teachers at high schools, doctors at local hospitals and journalists at local newspapers have seen the foundations of their economic lives destroyed and are being pushed into poverty, or completely eliminated from the economy.

This is no accident.

There is literally no one to be found in the neighborhood who has expertise to explain what is going on in the world. The elimination of community colleges and local universities means that most citizens have no chance to talk with the educated classes at all and must rely on the corporate controlled internet for information.

Even on the internet, biased algorithms for searches on Google, and secret restrictions on content for the media, or social networks, mean that committed intellectuals concerned about the future of the nation are rendered invisible for the common man.

These ethical intellectuals must form an organic relationship with the citizens (as Antonio Francesco Gramsci put it) that allows citizens to understand what is going on, and helps them to organize themselves, drawing on the knowhow of political reformers over the last three thousand years.

Organization of tightly-knit groups of citizens ready to take on the billionaires must be started by a core of such committed, revolutionary intellectuals. We must set up regular meetings of citizens to discuss their concerns and create systems for participatory governance at the local level. These discussions will train citizens to wean themselves from TV and other corrupt forms of corporate media, to raise their own intellectual horizons, and to engage in positive discussions with each other. Committed intellectuals need to explain how the political economy works, and how to survive, but also to help citizens to think for themselves, to be confident in their creativity and their ability to imagine, and to realize a better society.

Once they start to regain intellectual independence and self-confidence in their role as citizens under the Constitution, the people will be able to engage in their own meetings, and create their own organizations that will carry on the struggle at the local level. They will no need swindler patron saints like Trump or Obama any more.

Education

If we want the intellectual and institutional independence necessary to take on the billionaires, we must create immediately alternative schools for our children that not only avoid dangerous vaccines and PCR tests, but also offer an opportunity for children to learn to think for themselves without the brainwashing that corporations slip into public education through bribes, seen and unseen, to politicians and policy makers.

Such alternative schools, from kindergarten to graduate school, will be critical for establishing an independent citizenship capable of standing up to the billionaires. It does not have to be expensive.

Merely making a proposal for independent education run by citizens without any corporate funding will change the mood in politics. Moreover, many citizens are entirely qualified to serve as teachers, part time, for their own children and their neighbor's children. If we have the will, a new educational system can be launched quickly.

That project must include continuing education for citizens that allows them to meet regularly for discussions with ethically-committed intellectuals to learn about how the political economy really works, to study history and culture so as to understand our current situation. Continuing education must also cover practical skills such as how to raise one's own food, or to how to use herbs to cure illnesses, how to make your own clothes and furniture, and other steps to become independent from corporations

and government.

None of the money should come from foundations or corporations who have an interest in destroying the ability of citizens to think for themselves. No thanks, Carnegie Foundation! No thanks, Ford Foundation! No thanks, Rockefeller Foundation!

Learning to write and to create art must be a part of continuing education that empowers citizens to make their own music, create their own images, without relying on the branded content (music, texts and images), supplied by advertising firms working for multinational corporations. Commercial music and design is meant to put citizens to sleep, to brainwash them into accepting the fascist policies as normal. Citizens art, by contrast, can focus on real issues in our lives, and hint as how we can change our society with our own hands.

Education for citizens is the critical defense against the mentacide campaigns launched to destroy the ability of citizens to think for themselves. Mentacide means the destruction of, the “rape” of, the mind through trash music, videos, television shows, social media and other weapons. It is the front line in this class war.

Education is not the memorization of facts in order to qualify for a job. It is a process by which the citizen learns to think for himself, or herself, about the world, learns how to teach himself, and to use the scientific method and appropriate skepticism in the process of learning about the world every day.

Education is also about morality, about learning how to be a committed citizen by understanding the teachings from ancient times concerning ethical behavior and moral action.

Journalism

A critical extension of education is journalism that provides citizens with accurate and relevant information about our society and that challenges them to think for themselves. Needless to say, the corporate media does not offer journalism at all.

With the proper training, moral commitment, and the will, a small group of citizens can easily put together their own newspaper that presents information culled from various sources (including the corporate media) with proper annotation to make it accessible and relevant to citizens.

Journalism must address the issues that the corporate media tries to hide. It must, for example, expose the link between the introduction of technology and the increase in tyranny. Computers, automation and on-line shopping are not primarily about making life more convenient for citizens, but rather creating impenetrable realms wherein decisions can be made by corporations that impact our key constitutional rights, and do so without our knowledge, our consent, or our understanding.

Although we pay to purchase them, and pay a fee to use them, smartphones belong to corporations, not to us, and are constantly updated, and the information fed to corporate and government fusion centers without our knowledge or consent. More importantly, the stimulation of citizens by sexually suggestive programs, or information about food, fun and travel, is intended to destroy our ability to think independently and thus a blatant violation of our constitutional rights.

Unless we take a stand, we will be reduced to slavery, bit by bit, step by gradual step. Unless journalism exposes these tricks, citizens will remain unaware until it is too late.

Resistance by citizens to tyranny is critical for our independence and must be our highest priority.

Our intention is to completely replace corporate media and to create alternative education and alternative journalism that meets the needs of our citizens for their spiritual and intellectual independence. This goal cannot be accomplished overnight because those who have been brainwashed by corporate media for years will require significant engagement in our discussions and our debates to overcome their unhealthy dependencies. All of us have loved ones nearby who suffer from this tragic condition.

How to take down the Billionaires

Chapter 11

Taking the billionaires down one step at a time

The final stage of taking down the billionaires cannot be undertaken until the previous steps towards economic and intellectual independence are well underway. A rush to take down a symbolic figure like Bill Gates can easily backfire because he is not an isolated case, or a mastermind, but rather the symptom of a deeper malaise. There are plenty of billionaires who would be happy to throw Bill Gates under the bus if it allowed them to distract the people and continue with their war of extraction and control.

Moreover, most resistance movements are riddled with spies for the super-rich who pose as sincere citizens, but who offer useless, or counterproductive, suggestions. These spies and quislings want to keep citizens locked in a pattern of complaining and occasionally protesting without ever thinking concretely about how exactly how, and who, will seize the assets, and destroy the chain of command, that support these billionaires.

Once we have materials that explain in an accessible and scientific manner the nature of the criminal takeover of the government, we must use those materials in speeches, in handouts and in a true alternative journalism, to demonstrate that our organization adheres to the Constitution (which defines the nation) and it has a legitimacy that the criminal syndicates masquerading as government do not have.

When we are properly prepared, we can go forward and make our demands. That means demands for the resignation, or the arrest, of government officials who act as the cat's paws for the rich to support and justify their illegal actions. We must make uncompromising demands for the full release of all classified material concerning the 9.11 attacks, the COVID-19 pandemic, and other criminal conspiracies that effectively have destroyed government.

We must demand the end of rule by a shadow government administered by factions of intelligence and the military who report to the rich. Such demands must be backed up with concrete and unpleasant consequences for the criminals who refuse to comply.

Making such demands in a convincing, organized and committed manner, starting at the local level and working up, will be successful (whatever the initial setbacks may be) in turning the tide and in forcing resignations.

We must play from a position of strength. There is no room for compromise and if we must demand that everyone in the state legislature, or in the US Congress, or in the White House must resign, then we should do so firmly, and without hesitation. It is the Constitution, not fuzzy, happy impressions, that guides our hand.

Demanding strict adherence to the Constitution will undergird our revolution at every turn.

The Constitution, and the Declaration of Independence, empower the citizens to overthrow a corrupt government by revolution and the Constitution is a higher authority than any government agency, any corporation, any specific law or regulation.

The Democratic Party, the Republican Party, lobbyists, corporations and a host of other parasitic institutions that make policy today are not described anywhere in the Constitution and our citizens'

groups are entirely justified in demanding that these institutions play no role in the formation of, or the implementation of, policy; that they play no role in elections and that they play no role in the debate about what our country should be.

That ban obviously extends to all privatized government services (which are by their nature a violation of the Constitution) and all foreign power brokers that poke their noses into the process by which policy is formulated in Washington D.C.

Our organization must be so well organized and so systematically administered that it can play the role of a temporary government that follows the Constitution for the period required to clean house and to upgrade.

It is critical to avoid the vague attacks on “government” as an inherently evil institution that have become so popular. Billionaires pour cash into popular media figures and political movements that stress only the evil of government, or the failings of individual politicians like the aged and sad Joe Biden and Donald Trump.

Such discourse purposely fails to identify the process by which the rich manipulate government, and other institutions, for their own benefit, and how decisions on policy are made outside of government and then fed to politicians and officials through lobbyists and consultants.

We need a government. The government must be smaller, more focused, in accord with the Constitution, and made up of incorruptible and committed officials with a vision for what the United States can become.

Attacks on government that encourage fuzzy thinking, that blame everything on a few bad apples, or that suggest that government can never work, are extremely damaging to our efforts.

Government is necessary, although it will never be perfect, and it must constantly be monitored by aware citizens so as to make sure that it does not slip back into tyranny.

If we do not create some form of legitimate government, we will not be successful in combatting corporate fascism.

It will be government, after it is reborn, that will be able to arrest these criminals. We cannot simply say “lock them up.” We must build reliable and accountable institutions that are capable of locking them up. That is our primary task.

We should show sympathy for government officials who are struggling to do their jobs and we should welcome them to join us. At the same time, those who are involved in these conspiracies to subvert government for the benefit of billionaires should be clearly labelled as “criminals” and the organizations they control defined as “criminal syndicates posing as government organizations.”

Taking them down and locking them up

The final stage of the take down I will not try to detail here because it will become self-evident in the process.

We need a plan to identify what precisely the top 200 billionaires in the world possess, how they claim possession, what are the organizations and corporations who support their efforts, and the private

strategy and security teams that they employ directly to prepare and implement their strategy.

Once the details are clear, the legitimacy of their claims of ownership of money, and of assets, must be systematically undermined. The scale of their crimes must be made known to a broad audience in an accessible and scientific manner, and their lackeys and quislings must be persuaded to leave the sinking ship.

The final step is to seize their assets, bit by bit, and to isolate them step by step. We will challenge their claims to assets, their control of supercomputers and analysts at privatized intelligence operations, and finally end their ownership of land and militarized compounds.

Once that process is complete, arresting and charging them will be easy. If the process is not complete, if citizens are not sufficiently aware of the true nature of the crisis, if there are not enough people committed, or if the plans for what will be done are not sufficiently concrete, a premature effort to shut the billionaires down is doomed to failure.

Such failure will most likely take the form of some political savior, some economic messiah who offers economic equality and freedom but who is secretly funded by those billionaires.
